USA: GROWING AMERICAN FARMER PROSPERITY PROGRAM (FORMERLY FARMER INCLUSION) IN NORTH CAROLINA AND VIRGINIA: 2025 was a year of consolidation, expansion, and renewed momentum. After losing USDA funding, the program deepened farmer relationships, took steps toward long-term, farmer-centered impact across the Southeast, and mobilized new private and philanthropic funding. This diversification was an important step toward a more resilient financial model. The geographic expansion from North Carolina into Virginia, supporting a growing network of farmers adopting regenerative agricultural practices was a significant achievement. Supported by Cargill and built on trusted partnerships and existing farmer networks the program assisted more than 210 Black farmers across the two states. 2025 was also a year of systems-building; significant resources were dedicated to developing the foundations of a tech-enabled Revolving Loan Fund to address lack of affordable finance.

CANADA: FIRST 30X30 Indigenous-led conservation is essential to achieving national "30x30" biodiversity targets. While carbon markets have the potential to unlock long-term funding for Indigenous stewardship, early-stage financing remains scarce, preventing many First Nations from accessing these opportunities. In 2025, we advanced this mission: completed 3 pre-feasibility assessments (Market Opportunity Assessments, or MOAs) with Indigenous Nations, analyzing 600,000 acres of Indigenous territory; they represent the first step toward achieving approximately 16.7 million tonnes of sequestered and/or avoided CO2e emissions. First 30x30 has engaged 38 Nations across 6 provinces and territories. N4J secured a \$10 million 5-year grant from the BHP Foundation towards year-end. \$2 million was received in January 2026 and the remaining funds will be provided in the 3rd quarter or 2026. We have also received significant funding from RBC and expect additional funds in 2027.

AFRICA: NATURE-BASED SOLUTION PROJECTS: In 2025, we advanced our African NbS work laying strong foundations for long-term, community-centered impact. We completed a project plan and due diligence for ecological restoration covering 38,550 acres in South Africa in partnership with ACT Group, Ecosystemiq and Apex Conservation Services. It wil restoring degraded thicket ecosystems dominated by Spekboom, a resilient indigenous plant with ecological and climate protection value. N4J's Board approved establishing a registered local entity Nature For Justice South Africa. During 2026, this will enable the growth of an in-country team, strengthening local partnerships, and long-term delivery capacity. In Ethiopia, to advance regenerative agroforestry initiatives that place food security and farmer resilience at their core, we deepened our Alabaster International partnership to co-develop an Enset-based mixed agroforestry program.
